

## **PHOTOGRAPHY & VIDEOGRAPHY COMPETITION**

### Photography & Videography Competition Entry Requirements

The Photography & Videography Competition is one of the best **Climate Change** themed competition for locally produced content. Several creative formats are included in the competition, namely documentaries, short sketches, advertisements or public service announcement.

This competition is open to all Malaysian citizens residing in Malaysia. The competition is divided into two categories; **Photography and Videography**. The objectives for this competition are as follows:

1. To foster interest and creativity among Malaysians in promoting a green lifestyle;
2. To unleash talent among Malaysian citizens and providing opportunities in the creative content industry;
3. To cultivate Malaysian citizens awareness towards the environment and the effects of climate change on the country.

**Photography:**

Image Format: JPEG / High Resolution

File Size: Not more than 5 MB

Caption: Each picture must be accompanied by a rational caption not more than 20 words

**Videography:**

Duration of Participation: 3-5 Minutes

Video Format: 1080Hd MP4 / MOV

File Size: Not more than 100MB

**The Entry Date** for both categories starts on **16<sup>th</sup> September 2020** while the **Entry Closing Date** is on **13<sup>th</sup> October 2020**

A. Competition Information:

1. The Photography & Videography Competition is an initiative of the Malaysian Green Technology and Climate Change Center (MGTC) in collaboration with the Ministry of Environment and Water (KASA).
2. This competition is open from **16<sup>th</sup> September 2020** to **13<sup>th</sup> October 2020**.
3. The theme for this competition is **CLIMATE CHANGE** and each entry is required in Bahasa Melayu.

B. Terms and conditions of the competition:

1. Participation is free and open to all Malaysian citizens residing in Malaysia.
2. Entries must be submitted no later than 13<sup>th</sup> October 2020 to the Competition Secretariat and entries received after 13<sup>th</sup> October 2020 will not be accepted.
3. Photography entries must incorporate Climate Change element with a rational caption not exceeding 20 words.
4. Each participant is limited to submit 3 (three) photography entries only. However, only one of the best entries will be selected for juries' evaluations.
5. Videography Category entries must incorporate Climate Change elements with duration between 3-5 minutes that can form awareness towards climate change among the community.
6. Videography Category entries can be in the form of documentaries, short sketches, advertisements or public service messages.

7. Entries must demonstrate the Malaysian Society Values and does not offend any party.
8. Entries must be the original work of the applicant and never have participated in any national and international film / video festival.
9. Each Videography entries is limited to submit 2 (two) videography entries only. However, only one of the best entries will be selected for juries' evaluations.
10. Proof of delivery is not considered proof of receipt. An official confirmation email of acceptance will be issued by the Secretariat of the Photography and Videography Competition.
11. The Secretariat reserves the right to reject incomplete entries.
12. Pictures, videos and other materials received will not be returned.
13. Entry will be deem cancelled if the work submitted is not original / plagiarized.
14. The participant's winning title will be stripped and the prizes received will be withdrawn if the work is not original / plagiarized.
15. The decision of the Jury Panel is final. Any correspondence will not be entertained.
16. The copyright of production is the property of the participants. Participants must allow the Photography & Videography Competition to use the production for promotional and broadcast purposes before, during and after the competition.
17. Participants also must allow edits to be made on either photography and videography entries for the purpose of MGTC promotion and publicity.
18. Organizer will not be hold responsible for any form of production-related claims against participants by any party concerned.
19. The complete Entry Form must be accompanied by:
  - a. Photos / Videos of participation in the link that can be accessed by the Secretariat.
  - b. Certificate of participation is original work
